**Resumen:** En este trabajo se propone revisar las evidencias sobre el reinado de Jeroboam II cuarto rey de la dinastía de Jehú de Israel. Un rey sobre el cuál el texto bíblico no hace más que breves referencias. Sin embargo en los últimos años los cuestionamientos a la escuela deuteronomista y las evidencias epigráficas han posibilitado visibilizar a este rey. Jeroboam II permanece 40 años en el poder realizando alianzas con el entorno regional que habilitan a los historiadores a leer la evidencia en clave histórica para arrojar luz sobre una figura de poder al interior de la misma sociedad israelita.

**Abstract:** This paper aims to review the evidence regarding the reign of Jeroboam II, the fourth king of the Jehu dynasty in Israel, a ruler about whom the biblical text provides only brief references. However, in recent years, challenges to the Deuteronomistic school and epigraphic evidence have allowed for greater visibility of this king. Jeroboam II held power for 40 years, forging alliances within the regional context that enable historians to interpret the evidence from a historical perspective, shedding light on a figure of power within Israelite society.
